P	4. Take the 1st right to stay on Whittier Depot St . Map If you are on Whittier School Rd and reach Elliot Rd you've gone a little too far	0.2 Mi 1.0 Mi Total
r	5. Turn right onto Highway 19A . Map	0.08 Mi 1.0 Mi Total


